Dear David,

Please consider setting up a County Wide Streets & Roads Task Force. Getting all stakeholders involved could prioritize projects & obtain funding.

I am trying to improve North County neglected streets & roads. These problems have existed for decades.

The Hickey to Colma road problems goes back into the 1940's.

I talked to Sergeant Matthew O'Connor this morning.

The 2 problems that I complained about have been turned over to SSF Streets Dept.

This El Camino Real dead tree problem area may belong to Caltrans or the adjacent property owner.

The Monterey Cypress problem is now with PGE, CPUC, CALTRANS, SSF Street Dept, County Manager.

I have tried over many years to get Samtrans North County deficiencies improved.

Karyl Matsumoto got the broken windows in the Arroyo Drive shelter repaired.

It took 5+ years. The shelter is now in a much better location south of Arroyo Drive.

This is not the way to solve problems. There are too many cooks in the kitchen.

A County Wide Task Force could look for funding from USG, Caltrans, PGE to solve problems.

PGE created many problems they refuse to address. My shallow gas line is just one.

PGE has stonewalled me again. John Baker dropped the ball & kicked the can down the road again.

Brian Alexander has lied to John & me. He has a poor memory too.

When City Hall abolished the CPTF, they marginalized our ability to solve these safety problems.

I miss seeing Pedro & Ellie. I miss seeing Mel Addiego. They all still helped with cleanup projects.

Mike Harris trying to fix infrastructure deficiencies one piece at a time will not work.

Caltrans owns most of the adjacent area to the roadway along the Colma to Hickey roadbed.

A wall could be built here like on Hickey or JS. The rest is not so easy to fix.
