Chair John Baker called the meeting to order at 6:33 p.m. and led the Pledge of Allegiance.

PRESENTATION: PROPOSED SAMTRANS FARE ADJUSTMENTS

Rita Haskin, Executive Officer, Customer Service and Marketing reported:

- Objective:
 - o Generate revenue to assist with paying for operation of the service
 - Redi-Wheels farebox recovery is 6 percent and SamTrans farebox recovery is 18 percent
 - o In alignment with Board-adopted Strategic Plan
 - Increase efficiency as mandated by the Metropolitan Transportation Commission Transit Sustainability Project
- Fare History:
 - Last SamTrans fare increase was 2010
 - Last Redi-Wheels fare increase was 2010 for full fare and 2011 for Lifeline
- Communications:
 - Public notice and onboard Take One with Safe Harbor languages
 - o Onboard visual and audio messages in English and Spanish
 - Web button and information
 - Community-based organizations
 - Social media
 - Message to stakeholders



- Presentation to Paratransit Coordinating Council
- o Four public meetings
- Ways to comment:
 - o E-mail
 - Mail
 - o Phone
 - o At the public meetings
 - Public hearing on October 7
- Paratransit proposal is a \$0.50 increase in 2016 and 2019
- Fixed-route proposal:
 - Eliminate the express fare and out of San Francisco fare, move youth to same fare category as senior and eligible
 - Fare would increase \$0.25 in 2016, but if customer uses Clipper the increase would be \$0.05
 - There is no increase if senior and disabled customers move to Clipper
 - Youth age is being expanded from 17 to 18 years
 - o Two free children with a fare-paying adult, increased from one
- Way2Go Pass would increase in 2019 from \$125 a person to \$130 a person, with a minimum participation rate of \$13,000
- Next steps:
 - Review and consider all comments submitted
 - o Provide final proposal to Board in November for action

Sonny Koya said he is very satisfied with all the marketing to get the word out on the changes. He said he attended the public hearing in South San Francisco and there was only one other attendee and if people did not attend or send in comments they have no right to speak. Mr. Koya asked about the fare out of San Francisco. Ms. Haskin said it would be a local fare starting January 10.

Juslyn Manalo asked if there was any outreach to cities. Ms. Haskin said cities are on the news release mailing list, which included the dates and locations of the meetings. Some cities put it on their city websites.

Ms. Manalo said she likes the incentives for people using Clipper and allowing two free children with a fare paying adult.

Charlotte Laughon asked if staff is speaking to the low-income housing community in Half Moon Bay. Ms. Haskin said staff is going to speak to them, but this is not just for low income. A company could apply for this benefit.

Ms. Laughon said she had no issues with the price increases and believe it is very reasonable.

Bill Lock asked if there is a distribution by payment chart showing cash versus Clipper versus tokens. Ms. Haskin said the triennial survey will begin next month and one question being asked is how a customer paid.

Mr. Lock is concerned passengers won't have the income to pay the fare increase. He said tokens seem just as efficient as Clipper and asked why these fare mediums don't have the same increase. Ms. Haskin said tokens are 20 percent off the base on the cash fare and Clipper is 10 percent off the cash fare.

Annette Merriman asked how much information is getting distributed to the high schools. Ms. Haskin said information was distributed to all schools in the county.

Ms. Merriman asked if the students have anywhere on the Coast to load Clipper cards. Ms. Haskin said at Hassett Hardware on Main Street in Half Moon Bay.

Barbara Hasten said she is glad to hear Route 292 will become a local fare. She asked if the express buses can come back. Ms. Haskin said the San Mateo County Transit District has a structural deficit. The changes on express buses were based on data.

Bob Gomez said he did not hear the audio on the bus. Ms. Haskin said not all buses had the audio message.

Mr. Gomez asked if any of the fares are tax-deductible for passengers. Ms. Haskin said no.

Chair Baker said he is glad to see the discount on Clipper. He asked how 2019 was decided for an increase. Ms. Haskin said in the Strategic Plan it states fares should be increased every three years to have less impact on customers.

Chair Baker asked if the out of San Francisco fare change could become effective when the Board approves the other changes to eliminate confusion in January. He said if the fares are dropped to \$2 on Route KX ridership will increase.

REPORT OF THE CHAIR

Chair Baker thanked staff for selecting him to serve as chair for the remainder of the year. He was chair of the CAC about five years ago.

SAMTRANS STAFF UPDATE

Mr. Patton reported:

- August performance:
 - o Average weekday ridership was 41,427, down 0.3 percent.
 - o On-time performance was 84.3 percent, below goal of 85 percent.
 - o Complaints were high at 235.
 - o Miles between road calls was 25,381.
 - o Tokens continue to be popular.
 - o There were seven missed schedules.
- Follow-up items:
 - Bus stop sign has been replaced at Coastside Hope.
 - The vegetation has been trimmed at the Highway 1 bus stop by the hostel in Montara.



- Staff has asked the Bay Area Rapid Transit (BART) to clean the benches at San Bruno BART.
- Staff has determined it would be unsafe to execute a U-turn at the Veterans Administration in Menlo Park.
- o Five minutes has been added to the early Route ECR trip pull-out time.
- Staff inspected the bus stop at El Camino Real and Hickey Boulevard and found no deficiencies.
- Staff determined the shelter at bus stop #34077 needed repair or replacement and determined the shelters at Arroyo Drive were the old style with no lighting features.

Ms. Laughon said she received an e-mail from Supervisor Don Horsley stating the stops looked at only had one rider. Ms. Laughon would like these clarified. Mr. Patton said there is a report with the numbers in it and he will have it sent to Supervisor Horsley's office.

Mr. Koya asked what constitutes a complaint. Mr. Patton said service issues, operator rudeness, pass ups, late or early buses.

• Mr. Patton said Route 294 received weekend service with the SamTrans Service Plan. Service will be doubled for the Half Moon Bay Pumpkin Festival.

Ms. Laughon asked if the Coastside meetings can be combined with the Connect the Coastside meetings. Mr. Patton said he will pass this idea along to Public Affairs staff.

CAC MEMBER COMMENTS/REQUESTS

Mr. Koya said at the last meeting he had requested a bus shelter be moved on Bayshore Boulevard. He spoke with Karambir Cheema, Superintendent, Bus Transportation, and it has been decided to defer this move because of the elimination of the San Francisco surcharge.

Mr. Koya said when there are events in San Francisco that affect Route 292 there is usually an announcement on the buses. He said the event name shouldn't be announced as this is providing free advertising. Mr. Koya said MV Transportation has addressed the issue of buses being on time especially with the Giants games. He said cell phone usage has gone down, but eating on the buses has increased and wondered if operators can play the announcement about eating on the buses.

Mr. Lock said he took Routes 110, 112 and 120. The FogFest link to SamTrans stated to take Route 118, but that route doesn't run on the weekends.

Mr. Gomez said there will be two parades the weekend of October 2 and 3 in East Palo Alto that may cause increased traffic in the area.

Chair Baker asked if there has been any thought of adding a second Clipper reader so people could board in the back door. Mr. Patton said it is an idea that could be explored.
