Dear Chairman Powell,

As part of this year's appropriations process, it was just announced by the new Majority that Members of Congress may once again request Community Project Funding to directly fund nonprofit and public sector projects in their Congressional Districts, and I invite you to share with me a project you believe is a top priority.

The Appropriations Committee will only consider requests for certain funding accounts, and I've enclosed a list of accounts and their eligibility requirements for your reference. The Committee prioritizes requests with substantive community support in the form of letters from local elected officials, local press articles or editorials, local government resolutions, or other indications of local support.

If you have a project that I should consider submitting to the Committee, I need to hear from you no later than March 17<sup>th</sup> at 5:00 p.m. PDT so I can thoroughly review the information you share. 
