Hello Erin,

Thank you for reaching out. Operations Planning Manager Jonathan Steketee (copied) and I happy to meet and discuss Ride Plus and the potential to partner in Millbrae. *Please provide a few dates and times you and your team are available to meet after July 26 (Jonathan is on PTO between July 11-26)*. In the meantime, below is some background information for your reference.

SamTrans' Ride Plus is an on-demand service intended to increase public transit access in areas where fixed-route bus service is difficult. The Reimagine SamTrans study initially explored on-demand service in four locations: Foster City, Millbrae, Half Moon Bay, and East Palo Alto.

In the final approved plan, Reimagine SamTrans recommended Half Moon Bay and East Palo Alto as the two on-demand service areas. Half Moon Bay's rural location and limited road access make the area difficult to serve with fixed-route service, while East Palo Alto is largely cut off from the rest of the Peninsula by US-101. On-demand service makes it possible to connect riders to fixed routes that allow them to travel out of the area. Additionally, both Half Moon Bay and East Palo Alto are designated Equity Priority Areas with a higher concentration of riders who are low-income, identify as people of color, and do not have household access to a private vehicle, standing to benefit the most from on-demand service.

Service started in the two service areas in June 2023. The service is provided by an external vendor, and the existing contract goes through June 2026.

Thank you for contacting SamTrans, though we regret it was due to concerns you have with our proposed changes to our Route 120. Know that your comments and concerns were forwarded to the proper parties for review. A copy of this correspondence will also be sent to our Board of Directors.

Please note that, while an Environmental Impact Report is not required for urban planning efforts at this scale, SamTrans had worked with both the City and the school district to address community concerns about this proposal. We also had not expected our bus service to cause excessive noise to the neighborhood as we presently serve many similar neighborhoods without issue. Nevertheless, we understood how important it was to consider public feedback for a change such as this, so we listened to community members, like yourself, who had reached out to us about service update.

To that end, know that SamTrans has reevaluated this proposal using data from our findings and public input, and we have decided not to move forward with this update. Thank you again for taking the time to share your concerns about this proposal with us. We hope we can continue to provide you and the rest of our community with a safe and reliable transit system, though, in this case, doing so by ensuring our service does not run through your neighborhood.
