The San Mateo County Transit District (SamTrans) Board of Directors is accepting applications for two Public Member seats. Please complete the attached application and provide a current resume, if available. Applications are due Friday, November 1, 2024, by 5:00 pm.

To apply, you must be a resident of San Mateo County outside the coastal region of the County and cannot be an elected official or have served as an elected official within the previous 12 months. Public members are appointed to represent the diverse residents of the County.

The Public Members will be appointed by six members of the SamTrans board - the three members appointed by the Board of Supervisors and the three members appointed by the City Selection Committee. The seats will fill a term through December 31, 2028.

The SamTrans Board of Directors was formed in 1976 to meet the public transit needs of the County. The Board consists of nine members: three members appointed by the Board of Supervisors, two of whom are members of the Board of Supervisors and one who possesses expertise in the field of transportation; three members appointed by the City Selection Committee, who are council members at the time of their appointment; and three public members, one of whom is a coastal resident.
