### What is the Grand Boulevard Initiative?

- Collaboration between cities, agencies, nonprofits, and the private sector initiated in 2006
- Original vision: "El Camino Real will achieve its full potential as a place for residents to work, live, shop and play, and create links between communities that promote walking and transit and improve the quality of life."
- SamTrans is leading relaunch to focus on transportation challenges in San Mateo County



# **GBI's Objectives**



### Visioning

Create a unified, cohesive vision for transportation improvements along ECR in San Mateo County, building off past work.



### **Partnerships**

Create a forum for coordination and collaboration to reinvigorate past partnerships and forge new partnerships that enable implementation of ECR projects.



### **Implementation**

Address implementation challenges through alignment of policies and plans, providing technical assistance, and developing an Action Plan and coordinated Project Initiation Document.

# Transit Operations

Route ECR takes over two hours from Daly City to Palo Alto and has unreliable operating conditions



El Camino Real poses barriers to comfortably walking and biking



### Safety

El Camino Real has a disproportionate share of injury collisions as a part of San Mateo County's High Injury Network



### **GBI Agency Partners & Roles**



- Primary bus service provider in San Mateo County
- Coordinating countywide El Camino Real planning efforts with SMCTA



# Transportation Authority

- Funds transportation improvements in San Mateo County
- Directs funding towards El Camino Real projects



- Prepares the San Mateo County Congestion Management Program (CMP) and identifies strategies to relieve congestion
- El Camino Real is a CMP roadway



- •Owns and maintains El Camino Real as a state highway (SR 82)
- Reviews and approves proposed changes to the roadway



- Coordinates and funds Bay Area regional transportation
- Providing grant funding for El Camino Real planning and Caltrans approval efforts

# Priority Issues We've Heard from GBI:

# SAFETY

- Deteriorating, missing, or inadequate infrastructure such as crumbling sidewalks, potholes, and lack of storm drains
- Existing utility limitations
- **High stress, high injury**, high crash rates
- Lack of protected crosswalks and signals for traveling along ECR and across ECR
- Lack of protection from extreme heat and weather for those not driving
- High-risk travel choices like walking, biking, taking transit
- **High-speed** vehicle traffic
- **Disproportionate safety impacts** on those who walk, roll, bike, or take transit

# MOBILITY

- Complex interplay of deteriorating, missing, or inadequate infrastructure across jurisdictions
- Fragmented improvement efforts and priorities across jurisdictions
- Buses stuck in traffic and have suboptimal service
- Missing or discontinuous cycling and pedestrian facilities
- Poorly coordinated traffic signals
- Underperforming mobility spine that creates disproportionate challenges for low-income people or those who travel by modes other than driving
- Lack of high-quality alternatives to driving

# What is the **Grand Boulevard Initiative?**

Project Factsheet March 2025

### Project Overview

El Camino Real (State Route 82), more commonly known as El Camino, is a Caltrans-maintained road and the spine of San Mateo County. People want a safe experience on El Camino, whether walking, biking, riding transit or driving to get to downtowns, businesses, schools, and other destinations. The Grand Boulevard Initiative (GBI) will build on new momentum to re-envision the future of mobility on El Camino. SamTrans, the cities along El Camino, and the county are working together through GBI to better coordinate and more quickly advance improvements on the corridor.

SamTrans is sponsoring the first phase of a coordinated Caltrans project development process, called a Project Initiation Document (PID) for all of EI Camino Real in San Mateo County. Once complete, the PID will define the purpose and need for the changes along the corridor as well as potential design options.

The Grand Boulevard Initiative alms to transform El Camino Real Into a safe, inviting, connected, and transit-oriented boulevard.

### **Project History and Relaunch**

GBI first started in 2006 and secured over \$11 million in federal and state grants to support transportation and housing projects along the corridor. This relaunch coordinates local planning efforts on El Camino. GBI is led by SamTrans and brings Caltrans, neighboring cities, other public sector partners, and advocacy and public interest groups together with the GBI Task Force and Working Group. This relaunch is backed by \$2 million in funding by the Metropolitan Transportation Commission (MTC) with additional local match funding. The GBI relaunch aligns with ongoing state, countywide, and city plans.

### Central El Camino Real Multimodal Plan


- Focus on creating cohesive, locallydefined for multimodal vision for Central County cities in San Mateo, Belmont, San Carlos, and a portion of Redwood City

### Phase 1: Corridor Gaps & Needs

In the final phase, the team will present the preferred alternative and the implementation plan that will feed into the Caltrans project development process.


