### **Caltrain Celebrates One-Year Anniversary of Electrification**

Caltrain is celebrating its first year of electric service. Caltrain's historic Electrification Project was the first diesel to electric railroad transition undertaking in North America in a generation. The result has delivered more service that's faster to arrive at destinations, as well as a modern fleet that's quieter, more comfortable, and offering more amenities such as free Wi-Fi and accessible outlets.

Caltrain staff will be at stations this week to thank riders for supporting the first year of electrified service. We'll be handing out free swag and inviting riders to record a short video sharing their experience with the new trains and service.

Thursday, Sept. 25 from 9-11 am: Hillsdale, Redwood City, Mountain View, and Santa Clara Stations

Riders can expect free swag and useful transit information, in addition to a friendly hello as a thank-you for choosing Caltrain. Additionally, a number of elected officials and key stakeholders who helped make

electrification possible will be sharing their perspectives through a series of videos on Caltrain's social channels.

### August Marks the Third Consecutive Month of +1M Riders on Caltrain

The summer is winding down, but Caltrain's ridership is still going strong, with August 2025 having more than a million passengers, a 67% increase over August 2024. Average weekday ridership stood at just under 40,000, a 61.5% increase from last August. Weekend ridership has been up since the launch of electrification thanks to Caltrain's half hourly weekend service, but reached an all-time record in August with Saturday and Sunday ridership more than doubling since last August.

## Federal Issues

### **Appropriations**

- Federal funding expires Sept 30 and Congress must pass a CR to avoid a shutdown
- Historically during a shutdown, FTA operations financed by Highway Trust Fund or advanced IIJA appropriations would continue, but FTA unlikely to approve new grants
- Caltrain is awaiting approval for its federal formula grant agreement for new electric trains replacement vehicles
- FRA: 40% of employees furloughed, but safety inspection staff and other critical safety personnel working
- Agencies and the Administration have yet to issue guidance if no deal by Sept 30



# Federal Issues

### **Administration Update**

- On August 7, President Trump signed EO: "Improving Oversight of Federal Grantmaking."
- Order requires a Trump Administration appointee to review funding opportunity announcements and grant awards.
- Association with high-speed rail has led to reported reductions in grant funding for certain agencies.



## **Federal Issues**

## **Surface Transportation Reauthorization**

- Caltrain submitted comments to DOT on upcoming surface transportation bill.
- · Major issues:
  - Securing/preserving stable funding for passenger rail, especially safety enhancements
  - Strengthening passenger rail liability protections, risk management, modernization and strategic expansion
  - Enhancing coordination and streamlining regulatory processes, including for crossing improvements
- Current Surface Transportation bill expires Sept 30, 2026
- · Chairman Graves trying to pass reauthorization before the end of the year



# 2025 Legislative Session Recap

- Final votes of the Legislature Sept 13, 2025
- · Governor has until Oct 12, 2025 to sign or veto bills



# **Loan for Bay Area Transit Agencies**

## **State Bridge Loan for Bay Area Transit Agencies**

- \$750M loan for Bay Area transit agencies: AC Transit, BART, Caltrain, MUNI
- SB 105 (Wiener) and AB 105 (Gabriel) include language regarding full repayment of the loan principal, applicable interest rate, repayment schedule, and guaranteed repayment mechanism
- DOF and CalSTA to work with agencies to design short-term financing tools such as loans that align with operational needs, protect service, and support fiscal reforms, with clear and reliable repayment plans.
- Terms process completed by Jan 10, 2026



# SB 30 (Cortese) - Passed

Diesel-powered on-track equipment: decommissioning: resale and transfer restrictions.

- Prohibits public agencies from selling, donating, or transferring locomotives, even when an assessment shows potential environmental benefits.
- · Caltrain continues to have 9 diesel locomotives much of which run on the Gilroy segment
- Creates a loss of asset value for Caltrain of ~\$20-\$25M
- Ignores benefits of passenger rail in reducing VMT and GHGs through ridership.
- Incentivizes retaining older equipment, decreases available rolling stock, hinders fleet upgrades, and reduces revenue for public rail agencies.
- · Does not impact the private sector.



# SB 79 (Wiener) - Passed

Housing development: transit-oriented development

- If signed, SB 79 will make it legal to build more multi-family housing near rail stations and rapid bus lines, including in areas where such homes are currently illegal.
- The bill is intended to help lower housing costs by increasing the supply of homes in transit-adjacent areas, while also bolstering transit use and funding
- Caltrain is still analyzing all of the implications of the bill in its final form but expects
  there to be upzoning near many stations. How much will depend on factors including
  the zoning in place in the individual jurisdiction.

## **Updates on Supported Bills**

- · SB 71 (Wiener) CEQA Exemptions for Transit Projects Passed
  - Jumpstart public transportation and bike and pedestrian infrastructure projects by streamlining the permitting process.
- · AB 394 (Wilson) Transit Safety Passed
  - Expands existing legal protections by strengthening penalties for assaults against transit employees, broadening enforcement against trespassing on transit systems, and empowering courts to issue prohibition orders restricting access to individuals convicted of violent offenses against transit workers.
- · AB 476 (M. González) Metal Theft Passed
  - Aimed at curbing organized metal theft, strengthening enforcement tools for law enforcement and protecting vital public infrastructure from damage.

# SB 63 (Wiener and Arreguin)

Connect Bay Area Act

- Would authorize a 5-county regional transit funding ballot measure with expenditure plan that would cover Caltrain's projected annual operations deficit
- Establishes ad hoc committees of MTC commissioners from funding counties to review complaints and adjudicate operator performance with binding decisions
- Allows committees to recommend withholding up to 7% of funds for persistent noncompliance in areas such as service levels, cleanliness, and safety
- Urgency Clause was removed, so legislation does not go into effect until January 1, 2026



# SB 63: Next Steps

- · Passed California Legislature
- · Governor has until October 12, 2025 to sign the bill
- The bill would take effect Jan 1, 2026
- A measure, if created, would be on the November 2026 ballot



## **Cap-and-Invest Agreement**

### **Cap and Invest Agreement Reached**

- AB 1207 how funds are collected; SB840 how funds will be spent
- Three tiers; higher tiers funded first. No specific local projects called out.
  - Tier 1: \$233M/yr total: Green manufacturing and other programs
  - Tier 2: \$2B/yr total: \$1B/yr to HSR and \$1B/yr for legislative discretion (including \$125M in FY 26–27 for a transit pass program)
  - Tier 3: \$2B/yr total in continuous appropriations:
     \$400M for TIRCP, \$200M for LCTOP (Caltrain currently receives \$2.5M/yr)
     and \$1.4B for other programs such as CAL FIRE
- Note: Tier 3 continuous appropriations will now be fixed amounts rather than percentage of program revenues. Will not adjust with inflation.



**Re:** California High-Speed Rail Program Update

#### STATEWIDE UPDATE

### **Supplemental Project Update Report released**

On August 22, the California High-Speed Rail Authority (Authority) issued the <u>Supplemental 2025 Project Update Report</u>. This report to the Legislature outlines a clear path to achieve commercial success at the earliest possible stage, ensuring the system begins generating compelling economic return. It proposes several potential scenarios to advance the program, including completing the work now underway in the Central Valley by 2032, and connecting Northern and Southern California by 2039.

### **Steady Funding Agreement for High-Speed Rail:**

State legislators reauthorized the Cap-and-Invest Program on September 10, securing an historic \$1 billion for the high-speed rail project annually through 2045. Authority CEO Ian Choudri thanked state leaders and stated the agreement resolves all identified funding gaps for the Central Valley segment and further opens the door for meaningful public-private engagement. This is the largest guaranteed infusion of funding for the program to date.

### **Accelerated Timeline for 2026 Rail Installation**

On August 28, the Authority's Board approved proceeding with procurements to purchase high-speed rail materials, a major milestone to accelerate track and systems construction, slated to begin in 2026.

## 18th Cohort Graduates from the Central Valley Training Center

The Authority celebrated 16 new graduates of the Central Valley Training Center in Selma on September 8. With this graduating class, the Center has surpassed a major milestone – delivering more than 100,000 hours of training to students pursuing careers in the construction trades.
