On behalf of the San Mateo County Transit District (SamTrans) and the San Mateo County Transportation Authority (SMCTA), I am writing in support of Caltrain's application for funding from the California Energy Commission's Electric Program Investment Charge (EPIC) Program for the Energy Storage Project. This project demonstrates the integration of advanced energy storage systems with electric rail traction power infrastructure.

Funding for this project will enable Caltrain to capture regenerative braking energy and optimize the efficiency of electrified rail infrastructure. By storing this energy and discharging it during peak demand times, the project reduces strain on the grid and improves the efficiency and resiliency of Caltrain's electrified system.

This project provides meaningful safety, reliability, and sustainability benefits. By maintaining on-site energy during grid disruptions, Caltrain can provide continuous electric commuter rail operations and ensure passenger safety during widespread outages.

There are also economic and equity benefits. Many low-income communities rely on public transit as their primary mode of transportation. Because transit electricity costs are largely recovered through local sales taxes and rider fares, avoiding unnecessary energy costs directly reduces the burden on riders and taxpayers.

The successful demonstration of an advanced energy storage system is of significant interest to SamTrans as we look for innovative ways to support our zero-emission fleet transition, including electric buses and paratransit vehicles. Many of the touted project benefits Caltrain seeks could also help SamTrans improve its operations in the future, especially during power outages and unforeseen events.
