#### Mobility Management Report - ADA Paratransit

David Olmeda, Chief Operating Officer-Bus, provided an update that included metrics on ridership, registrants, on-time performance, passengers per hour, fleet reliability, and service complaints. There are 37,000 trips per year.

- Ridership is stable
- Number of registrants has leveled off
- Service quality is excellent
- Customer satisfaction is very high, complaint rate is very low
- Paratransit service is vital to the community



The Board requested information on where paratransit riders reside by zip code and how many paratransit registrants are actual users of the service.

#### Multimodal Ridership Report - October 2017

Average Weekday Ridership - October 2017 compared to October 2016

- Grand Total 165,020, a decrease of 0.6 percent
- Bus 40,670, a decrease of 4.4 percent

- Shuttles 12,670 a decrease of 2.2 percent
- · Caltrain 61,830, an increase of 5.1 percent

#### Dashboard Report: July - September 2017

- Improvement in Total Complaints and Did Not Operate categories
- Farebox Recovery Ratio is down from last quarter
- Continued loss of ridership
- · Slight decline in On-Time Performance

October 10, 2017

#### WELCOME/INTRODUCTION:

Mike called the meeting to order at 11:15a.m.and welcomed all to the PCC Retreat.

#### APPROVAL OF THE SEPTEMBER PAL MINUTES:

Dinae Cruise motioned to approve the September meeting minutes and Mike Levinson seconded the motion.

#### APPROVAL OF THE SEPTEMBER PCC MINUTES:

Nancy Keegan motioned to approve the September meeting minutes and Barbara Kalt seconded the motion.

#### **RETREAT REPORTS:**

#### A. EXECUTIVE COMMITTEE

Mike Levinson mentioned that the Executive Committee met this month and will place the continuation of saying the Pledge of Allegiance on the agenda at the November 14<sup>th</sup> PCC meeting.

#### B. REVIEW OF THE REGIONAL CONFERENCE 2017

On Tuesday, February 21, 2017, the San Mateo County Paratransit Coordinating Council hosted a Regional Conference, "Beyond ADA." The conference was held at the SamTrans Headquarters building in San Carlos, CA. In attendance at the conference were Paratransit Coordinating Council (PCC) representatives, paratransit providers, paratransit customers, transit agency representatives, transit planners, and transit consultants from five of the nine Bay Area Counties. Representatives from the SamTrans

Board of Directors and San Mateo County Field Representatives for California State Legislature offices were also in attendance.

Richard Weiner reviewed the topics from the Regional Conference in February 2017. Conference attendees gathered into breakout groups, shared their experiences and opinions on the following topics: Other Same-Day Service Options (not taxis or Transportation Network Company (TNCs), Use of Taxis and TNCs in Service to People with Disabilities, Effectiveness of PCCs & Protocols Used for Inter-County Transfers, and other Best Practices in Paratransit Services. Some of the highlights of that conference follow:

- Taxi Companies are suffering with the use of TNC (Lyft and Uber types of competition). Participants said there were issues regarding the screening of TNC drivers. It was suggested that a surcharge be placed on the TNC drivers to contribute funding to the California Public Utilities Commission (CPUC) to regulate them. Fremont has tried working with the TNC due to lack of control and oversight of drivers' hours. It was noted that sometimes drivers are members of both Lyft and Uber. This can present a hazard to the community if drivers' focus is limited due to lack of sleep when drivers shift from one company to the other at the end of their work shift.
- There was a concern that there was insufficient availability of vehicles to accommodate people who use wheelchairs and that some TNC drivers have refused to allow service animals in their vehicles.
- Participants said there is a growing need for affordable paratransit fares for low income consumers (in other counties that do not have comparable program to San Mateo County).
- Participants stated that ongoing sensitivity training is needed for bus operators.
- East Bay Paratransit provides customers a booklet with emergency instructions which may be useful in other systems.

<u>Action Item:</u> Richard to Weiner will contact Annette Williams, San Francisco Municipal Transportation Agency (SFMTA) to get a copy of a report with recommendation on providing guidelines for the equity of TNC alternatives in San Francisco. Richard suggested contacting Drennen Shelton, MTC staff regarding hosting the next regional conference.

#### **SIGNIFICANCE**

Table "A" summarizes the average weekday ridership (AWR) statistics for all modes of transportation for which SamTrans is responsible and Table "B" summarizes the total monthly ridership figures for all SamTrans transportation modes. Chart "A" features year-to-date comparisons of AWR for Fiscal Year (FY) 2016, FY2017, and FY2018. Chart "B" has figures for total ridership year-to-date for FY2016, FY2017, and FY2018.

Tables "A" and "B" also provide the corresponding data for the Bay Area Rapid Transit San Francisco International Airport Extension as a separate line.

Table "C" details the number of riders for each fare category for SamTrans fixed route for the month and calendar year-to-date.

Table "D" provides additional information regarding SamTrans performance standards, including On-Time Performance, the number of Complaints received, and the number of schedules not operated due to unplanned circumstances (DNO).







#### **ACTION**

Staff proposes the Committee recommend that the Board accept and enter into the record the Statement of Revenues and Expenses for the month of November 2017 and supplemental information.

This staff report provides a brief discussion of significant items and trends on the attached Statement of Revenues and Expenses through November 30, 2017. The statement has been designed to follow the Agency wide line item rollup as included in the adopted budget. The columns have been designed to provide easy comparison of year to date prior to current actuals for the current fiscal year including dollar and percentage variances. In addition, the current forecast of Revenues and Expenses is compared to the Adopted Budget for Fiscal Year 2018.

#### **SIGNIFICANCE**

Annual Forecast: The Forecast reflects a deficit of \$3.4 million compared to a \$6.0 million projected deficit in the revised budget (page 1, line 35). This is an improvement of \$2.7 million. The variance is driven by savings in Motorbus expenses (page 1, line 19) do to lower Professional Services (page 3, line 7), Technical Services (page 3, line 8), Fuel and Lubricants (page 3, line 12), Contracted Urban Bus Service (page 3, line 35). There was additional savings in A.D.A Programs (page 1, line 20). The Motorbus and ADA savings of \$3.8 million is partially offset by a decline in Passenger Fares (page 1, line 1) of \$1.2 million.

**Year to Date Revenues:** As of November year-to-date actuals, the Total Sources of Funds (page 1 of the Statement of Revenues and Expenses, line 15) are \$1.2 million lower than the prior year. This is driven by a decline in revenues from Passenger Fares (page 1, line 1), Operating Grants (page 1, line 4), SM County Measure A & Other (page 1, line 6) due to a reduction in paratransit funding for FY2018, and Other Interest, Rent, & Other Income (page 1, line 12), partially offset by higher District ½ cent Sales Tax (page 1, line 10).

Year to Date Expenses: As of November year-to-date actuals, the Total Uses of Funds (page 1, line 33) are \$6.4 million higher than the prior year-to-date actuals. This is primarily due to Total Motorbus expenses which are higher by \$1.5 million (page 1 line 19) due to inclusion of unfunded CalPERS and Other Post-Employment Benefits (OPEB) liability (this expense, which was incurred in July, will not recur throughout the year), ADA Programs are \$1.0 million higher than prior year (page 1, line 20) due to new insurance claims, and Sales Tax Allocation for Capital Programs (page 1, line 29) which was not broken out in prior years.

#### **BUDGET IMPACT**

There are no budget amendments for the month of November 2017.

### ACTION

### **SIGNIFICANCE**

The CAFR is prepared in accordance with the guidelines set forth by the Government Accounting Standards Board and is organized into four sections – Introductory, Financial, Statistical and Single Audit.

- The **Introductory** Section includes a Transmittal Letter and provides general information on the District's structure, personnel, economic outlook and finances.
- The Financial Section includes audited financial statements which provide detailed financial information as well as comparative financial data. The Management Discussion & Analysis (MD&A) is also found in the Financial Section. Along with the Transmittal Letter, the MD&A is of most interest to those looking for a narrative annual review of the District's finances.
- The Statistical Section provides a broad range of data covering key financial trends including revenue and debt capacity, economic and demographic data and operating information.
- The Single Audit Section provides the Independent Auditor's Report on Internal controls and compliance, and the Schedule of Expenditures of Federal Awards and Findings and Recommendations from the Auditors.

Together, all sections of the CAFR provide the detail as well as the perspective with which to assess the District's financial condition.

### **BUDGET IMPACT**

There is no impact on the Budget.

### **BACKGROUND**

The District contracts with an independent auditor, Vavrinek, Trine, Day & Co. LLP (VTD) to conduct yearly audits of the Financial Statements in accordance with auditing standards generally accepted in the United States of America and the standards applicable to financial audits contained in Government Auditing Standards, issued by the Comptroller General of the United States of America. The introductory section and the statistical section presented in the CAFR are not required by California Government Code to be reported as part of the audited financial statements of the District. These sections are required when producing a CAFR which the District chooses to do in order to provide detailed information about the financial condition of the District in a form that is understandable to our customers and constituents.

The CAFR is prepared and presented to the Government Finance Officers Association (GFOA) for their review, evaluation and to apply for the certificate of Achievement for Excellence in Financial Reporting. The District has received an award for every year that the report was submitted.

55 HEAVY-DUTY DIESEL ARTICULATED BUSES

### **ACTION**

Staff proposes the Committee recommend the Board:

- 1. Award a contract to New Flyer of America, Inc. (New Flyer) of Winnipeg, Manitoba, Canada for 55 new heavy-duty, low-floor, 60-foot diesel articulated buses, for a total estimated amount of \$48,972,000.
- 2. Authorize the General Manager/CEO to execute a contract in full conformity with the terms and conditions of the Washington State Department of Enterprise Services Master Contracts and Consulting Unit's (DES) competitively bid contract and in a form approved by legal counsel.

### **SIGNIFICANCE**

Award of the contract will allow the San Mateo County Transit District (District) to replace fifty-five 2002 diesel articulated buses manufactured by North American Bus Industries. This fleet has reached the end of its useful life and is programmed for replacement, which will ensure continued reliable service for passengers and is in accordance with the replacement schedules of the Federal Transit Administration (FTA) and Metropolitan Transportation Commission.

### **BUDGET IMPACT**

Funding for the purchase was approved in the District's Fiscal Year (FY) 2015 Capital Budget (approved through Resolution 2014-28, dated June 4, 2014) in the amount of \$24,096,385 and in the FY 2016 Capital Budget (approved through Resolution 2015-32, dated June 3, 2015) in the amount of \$24,875,615 for a total approved Capital project budget of \$48,972,000. The purchase is fully funded with FTA funds in the amount of \$44,875,615 and State funding for the remaining balance.

#### **BACKGROUND**

On December 4, 2015, President Obama signed the Fixing America's Surface Transportation (FAST) Act into law, which provides long-term funding certainty for

surface transportation infrastructure planning and investment. Section 3019 of the FAST Act allows grantees to purchase rolling stock and related equipment from a state's cooperative procurement contract or schedule. The DES cooperative contract provides public agencies with the ability to purchase transit buses of various configurations from approved vendors that have been selected through a competitive sealed bid process. The DES has granted authorization to the District to use this contract, thereby enabling the purchase of vehicles that meet proven design and construction standards which will be configured to the District's specifications, at highly competitive prices.

WHEREAS, a combination of Federal funds and State funding sufficient for the purchase of the 55 diesel buses was budgeted in prior years' approved District capital budgets; and

WHEREAS, the General Manager/CEO recommends and the Committee concurs, that a contract be awarded to New Flyer of America, Inc. (New Flyer) of Winnipeg, Manitoba, Canada for a total estimated amount of \$48,972,000, including applicable charges for taxes, fees, and delivery.

NOW, THEREFORE, BE IT RESOLVED that the Board of Directors of the San Mateo County Transit District awards a contract to New Flyer of America, Inc. through the Washington State Department of Enterprise Services Master Contracts and Consulting Unit's contract for the purchase and delivery of 55 heavy-duty low-floor 60-foot diesel buses for a total estimated amount of \$48,972,000; and

\$850,000 FROM \$16,373,081 to \$17,223,081 AND AN INCREASE TO THE CONTRACT CHANGE ORDER AUTHORITY BY \$450,000 FOR THE SAN CARLOS

TRANSIT CENTER PROJECT

### **ACTION**

Staff proposes the Committee recommend that the Board:

- 1. Amend the Fiscal Year (FY) 2018 Capital Budget by \$850,000 from \$16,373,081 to \$17,233,081 to provide the requisite budget authority to fully implement the San Carlos Transit Center Project (Project); and
- 2. Increase the General Manager/CEO's contract change order authority by \$450,000 for the Project contract with Interstate Grading & Paving (Contract).

### **SIGNIFICANCE**

An increase in Contract change order authority and Project budget will enable the completion of the construction of a relocated San Carlos Transit Center parking lot between San Carlos Avenue and Arroyo Street in San Carlos and will allow for the development of the San Carlos Transit Village on the site of the existing San Carlos Caltrain station parking lot. The value of additional change order authority required to close out the Contract is \$450,000, primarily due to a significant delay by Caltrans in issuing an encroachment permit required to complete the work. Authorizing this increase would bring the General Manager/CEO's total change order authority for the Contract to \$829,100.

#### **BUDGET IMPACT**

To fund the remaining construction and project management costs, a budget amendment of \$850,000 is required. This amendment reflects the expenditure of the original \$379,100 contingency for the Project, and the requested additional \$450,000 in Contract change order authority.

The cost increase will be funded by Proposition 1B Public Transportation Modernization, Improvement, and Service Enhancement Account Program (PTMISEA) funds that are available for allocation. This amendment would increase the Project cost from \$6,230,214 to \$7,080,214 and increase the total FY2018 Capital Budget from \$16,373,081 to \$17,223,081.

### **BACKGROUND**

Per Board Resolution No. 2015-61, the original Contract award amount was \$3,791,000. The General Manager/CEO's Contract change order authority for the Project is 10 percent of the total original Contract amount, or \$379,100. The Board approved Resolution No. 2017-12 on March 1, 2017, which increased the Project's budget to \$6,230,214.

An amendment to the Capital Budget to increase the Project budget by \$850,000 will fund additional Contract change orders and remaining project support. An increase of \$450,000 in the General Manager/CEO's Contract change order authority will enable execution of the outstanding change orders.

WHEREAS, the General Manager/CEO's original Contract change order authority was established at 10 percent of the total Contract amount, or \$379,100; and

WHEREAS, as a result of delays by Caltrans in issuing an encroachment permit to perform the work, the combined total of executed and known outstanding change orders will exceed the existing General Manager/CEO's Contract change order authority by \$450,000; and

WHEREAS, the Board approved Resolution No. 2017-12 on March 1, 2017, increasing the Fiscal Year (FY) 2017 Capital Budget to \$16,373,081, which included an increase of \$1,245,749 to the Project budget for a total Project budget of \$6,230,214; and

WHEREAS, staff recommends, and the Committee concurs, the General Manager/CEO's Contract change order authority be increased by \$450,000, resulting in

### Federal Update

The Fiscal Year 2018 Appropriations process on funding expires December 8 and there's an active discussion on a continuing resolution. President Trump tweeted this week that there may be a government shutdown.

Tax Reform - There are two bills that have passed; one through the House and one through the Senate. Of note is that there were several Republicans that voted against the bills because of the provisions that affect California, New York and New Jersey. The Bills would go back to both Chambers for a final vote. Right now they're scheduled to try and wrap this up by Christmas.

### State Update

They are in recess right now but they're going to reconvene on January 3. Staff is keeping a close watch on Senate Billl 1 repeal. The California Transit Association has been active on educating its members on this.

The 2018 Legislative Program (Program) is intended to be broad enough to cover the wide variety of issues that are likely to be considered during that time and flexible enough to allow the Agency to respond swiftly and effectively to unanticipated developments.

### ACTION

- 3. Reinforce and expand programs that build and incentivize public transportation ridership and improve quality transportation choices.

The Program is structured to apply these core objectives to a series of issues detailed in the 2018 Legislative Program.

Should other issues surface that require the District's attention, actions will be guided by the three policy objectives listed above. If needed, potential action on issues that are

unrelated to these policy goals will be brought to the District's Board of Directors for consideration.

### **Advocacy Process**

Staff will indicate on each monthly legislative update recommended positions for pending bills. Once the board has an opportunity to review the recommended position, staff will communicate the position to the relevant entity (such as the bill author, agency, or coalition). high-speed rail service. Under a multi-party regional funding agreement, this investment will be used to match a variety of local, regional, state and federal funding sources to electrify the corridor, install an advanced signaling system and replace Caltrain's aging diesel trains with electric trains that will dramatically improve service between San Francisco and San Jose.

### Other Projects Beyond the CalMod Program,

Caltrain has identified capital projects such as a fully electrified 8-car EMU fleet with longer platforms that will provide additional capacity and service benefits to Caltrain commuters. The capital needs also include but are not limited to grade separations and station upgrades.

In 2016, a new round of HSR Blended System planning, outreach and environmental clearance work kicked-off in the corridor. While this project is not being led by the JPB, the agency owns the right-of-way and has a significant interest in the process and success of the project that will "blended" with Caltrain service.

## SamTrans Federal Update December 2017

#### **CONGRESS**

Congress Anticipated to Move on Final Tax Bill: House and Senate Republicans have reached consensus on the tax reform legislation, *The Tax Cuts and Jobs Act*, H.R. 1. On December 15, the tax conferees filed the conference report in the House. The Senate passed the bill early on December 20 in a 51-48 party line vote, after a procedural hurdle that delayed the vote by a day. The House had originally passed the bill in the evening of December 19, but several provisions in the plan violated Senate budget reconciliation rules. Senate Democrats stripped the problematic provisions, removing an excise tax on endowments of the smallest private universities; 529 savings accounts for home-schooling expenses; and the bill's shorthand title. After the House votes on the bill again (sometime on December 20), it will be sent to the White House for the President's signature.

The final agreement has retained more provisions from the Senate's version of the bill, though House Ways and Means Committee Chairman Kevin Brady (R-TX) said the final bill marked a mix between House and Senate plans. Democrats argue that the bill would be a break for corporations and wealthy individuals.

The transportation provisions in the conference report include:

- Retention of private activity bonds;
- Preserving the electric vehicle tax credit;
- Elimination of the bicycle commuter credit;
- Repealing the ability of employers to deduct the costs of parking and mass transit benefits provided to employees as a business expense;
- Repealing new advance refunding tax exempt municipal bonds; and
- Clarification that aircraft management services are not subject to the 7.5 percent commercial ticket tax.

FY 2018 Appropriations and Disaster Relief Update: On December 7, the House and Senate passed a two-week continuing resolution (CR), funding the government until Friday, December 22. The House passed the CR by a vote of 235 to 193, and the Senate passed it by a vote of 81 to 14.

Before Congress can pass a fiscal year 2018 appropriations bill for an entire year, they need to agree to change the dollar amounts of the caps on discretionary spending. If the caps are not adjusted, any enacted full-year appropriations will be automatically reduced via another round of budget sequestration to get back down to the cap levels.

Republicans want to significantly increase defense spending (a \$70 billion increase), but to garner Democrats' support (needed in the Senate as 60 votes are required for passage), an increase in non-defense spending is necessary as well.

On December 13, House Republicans introduced a third <u>CR</u>, to extend current government funding – which is set to expire on Friday, December 22. The CR includes \$663 billion for the Department of Defense for fiscal year 2018 and would fund the rest of the federal agencies (including the Department of Transportation) at current funding levels. until January 19, 2018; a five-year extension of the expired Children's Health Insurance Program (CHIP); and \$2.1 billion for the Veterans Choice program. Democrats have criticized the CHIP reauthorization provision, as it is offset by increasing Medicare premiums for higher-income beneficiaries, and shortens the grace period for individuals to pay their premiums through a tax credit.

The Senate is unlikely to pass the House bill given that it does not address increasing non-defense spending and the offsets for CHIP. The Senate is expected to amend the House CR through a substitute amendment and send it back to the House before they adjourn for the session. The Senate may also add an extension of the Foreign Intelligence Surveillance Act (FISA), which is set to expire this year.

On December 18,, the House Appropriations Committee introduced a \$81 billion disaster aid package to fund hurricane and wildfire recovery, which may be combined with the third CR. The funding is split among Texas, Florida, Puerto Rico, the U.S. Virgin Islands, and states impacted by wildfires. The bill includes money for the Federal Emergency Management Agency (FEMA) and Community Development Block Grant (CDBG) programs, reconstruction projects from the Army Corps of Engineers, education programs, highway rebuilding, small business loans, and military construction projects. House Appropriations Committee Chairman Rodney Frelinghuysen (R-NJ) said the bill represents the largest ever disaster aid funding effort, and was a crucial part of the government's response to the several natural disasters that impacted the country over the year. The bill is also nearly double the Administration's \$44 billion aid request. The funding is broken down as follows:

- Community Development Block Grants: \$26.1 billion
- **FEMA:** \$27.6 billion
  - o Includes Disaster Relief Fund (DRF) funding
  - A provision allowing transfer of up to \$4 billion to the Disaster Assistance Direct Loan Program Account for Community Disaster Loans
  - A provision providing up to 90% federal cost share for disasters declared in 2017 for wildfires
  - o \$60 million for FEMA's readiness for future disasters
- Army Corps of Engineers: \$12.1 billion
- **Department of Agriculture:** \$3.8 billion
- Hurricane Education Recovery: \$2.9 billion
- Reparations for Army, Navy, Marine Corps, Air Force, Reserve, National Guard, Coast Guard, and medical military facilities: \$1.5 billion
- Current damages to federal highways from designated disasters: \$1.4 billion
  - o Funds are provided directly to states and localities for repairs

- Includes \$269 million to help communities restore hurricane-damaged mass transit systems
- Economic Development Grants: \$600 million
  - o Projects may include technical assistance, planning, and infrastructure projects to aid economic recovery in hurricane and wildfire disaster areas.

Senate AV Bill Stalled: The Senate bill on autonomous vehicles (AV), S. 1885 The AV START Act, lacks the necessary support to advance under unanimous consent. On December 1, Sens. Richard Blumenthal (D-CT) and Ed Markey (D-MA), said that they would hold up the bill to urge inclusion of measures on consumer protections and safety. During markup of the bill in October, Sen. Blumenthal had introduced an amendment—which was later withdrawn—that sought to establish a provision requiring autonomous vehicles (AVs) to allow human drivers to take control. Sen. Gary Peters (D-MI), a bill sponsor who opposed Blumenthal's amendment, said requiring human control would "undercut the entire purpose" of driverless cars. However, Sens. Blumenthal and Markey have said they will continue discussions with bill sponsors, Sens. Peters and Senate Commerce Committee Chairman John Thune (R-SD). The Senate Commerce Committee and leadership are expected to work though the holds next year to pass the bill and conference it with the House legislation.

#### **ADMINISTRATION**

White House May Release Infrastructure Principles in January: The White House indicated on December 7th that President Trump intends to send Congress detailed infrastructure principles in January, potentially around the State of the Union address scheduled for January 30. The document would outline a \$1 trillion plan, in which a \$200 billion federal share would be split into four themes: funding for states and localities that take on a greater amount of financial burden for infrastructure building and upkeep; block grants for rural areas; existing federal loan programs; and money for projects deemed "transformational." It is anticipated that the plan will incentivize state and local governments to take on a greater share of costs for infrastructure projects, both through their own funding and through private-sector financing.

<u>FHWA Nominee Withdraws from Consideration</u>: On December 11, Paul Trombino, previously nominated by the President to head the Federal Highway Administration (FHWA), removed himself from consideration due to family concerns. Senate Environment and Public Works (EPW) Committee had approved Trombino's nomination, and he was predicted to easily move through full Senate confirmation. A new nominee has not been named.

## **November 2017 Summary**

The Training Department issued a Safety Campaign for the month of November – "Clearance Around Buses". The campaign provided situational awareness and focus to the minimum clearances a bus must have while making turns.

 SamTrans Maintenance Instructors assisted two deputies of the San Mateo County Sherriff's Office Transportation in obtaining their Class B License.

#### **Bus Operator Shortage:**

The public transportation industry has a Bus Operator shortage. Recruiting and background checks for newly hired Bus Operator Trainees takes approximately two months. SamTrans provides eight weeks of training before a Bus Operator Trainee is allowed to operate independently in revenue service. SamTrans has 308 authorized bus operator positions; it also has an attrition rate of two to three, and as high as four, Bus Operators per month. SamTrans conducts three to four trainee classes per year in order to manage service needs and attritions. Small classes provide individual attention to each trainee and operational flexibility.

- Class #150 graduated eight Bus Operator Trainees in November 2017
- Class #151 started with eight trainees but is projected to graduate five Bus Operator Trainees in January 2018

 No school trips were lost. The 66 DNOs in November are higher than SamTrans' monthly average, but it is still very low with approximately 0.014% of 48,000 total trips during the month of November. Bus Operator availability and shortage is a contributing factor to the higher DNO performance.

#### Runbook 125 effective January 21, 2018:

- "Sliding Seats" for SamTrans' directly operated routes will be implemented with RunBook 125 starting in January 2018. The "Sliding Seats" program is an industry best practice to provide Bus Operators relief along the service route while maintaining the revenue vehicle in service. "Sliding Seats" were implemented in August 2017 with select contractor operated routes. The program is deployed on a small scale to work out any service issues while accustoming the employees.
- A few routes will be combined to simplify service and make it more user-friendly.
- Route 118 from Linda Mar to Colma BART, will be extended to serve Daly City BART.

## Redwood City Holiday Parade

SamTrans Maintenance Department in collaboration with Bus Transportation decorated a SamTrans bus featuring Christmas lights, assorted holiday decorations, gifts on the top of the bus and with an active snow making machine. Staff members along with their families, participated in the handing out Santa hats and interacting with exuberant Redwood City attendees.

## SamTrans Fare Study

Staff kicked-off the SamTrans Fare Study in November 2017. While fares in the past have been adjusted periodically, new fares will go into effect in 2019. The fare study takes a fresh look at the universe of fare policies and recommends a framework to establish a new fare policy for the District. The fare study will create an elasticity model which will inform the District of how fare changes can affect ridership and revenue. The internal project team is comprised of interdisciplinary subject matter experts from Planning, Operations, Finance, and Marketing Departments. The study is scheduled to be completed by the summer of 2018.
