#### 1. CALL TO ORDER/PLEDGE OF ALLEGIANCE

Chair John Baker called the meeting to order at 6:30 pm and led the Pledge of Allegiance.

Iris Chan joined the meeting at 6:33 pm.

#### 3. PUBLIC COMMENT FOR ITEMS NOT ON THE AGENDA

#### **Public Comment:**

SamTrans Board Director Rico Medina and Vice Chair Peter Ratto thanked the CAC for their dedication to transit and serving on the Committee.

### 4. APPROVAL OF MEETING MINUTES FROM OCTOBER 27, 2021

#### 5. PRESENTATION: UPDATE ON SMCTD WEBSITE REPLACEMENT PROJECT

Jeremy Lipps, Digital Communications Manager, provided the presentation.

Alex Madrid asked if the new website would have accessibility features. Mr. Lipps said yes and added that the documents from the old site would need to be converted before moving to the new site.

Meredith Park asked if the mobile app would be changing as well as the website. She said there should be an emphasis on youth ridership.



Vice Chair Scott Johnston asked if there would be a public kiosk version. Mr. Lipps said that that may require some infrastructure purchases. Nancy Lacsamana said she liked the idea of having a display at a ticket kiosk.

Chair Baker said he appreciated the website survey. He said he looked forward to the new website.

Mr. Lipps said he would provide a link for CAC members to provide further feedback.

#### 6. REPORT OF THE CHAIR

Chair Baker opted to be on the Chair/Vice Chair Nominating Committee for 2022 and Ms. Park and Bianca Randall also volunteered.

#### 7. SAMTRANS STAFF UPDATE

Tina Dubost, Manager, Accessible Services, reviewed the highlights of the staff report.

Vice Chair Johnston asked what cover your brakes at intersections meant. Ms. Dubost said it means for the operators to be ready for anything. He asked about the signal priority project. David Olmeda, Chief Officer, Bus, said the signal priority on El Camino Real does not make a large difference in travel time, and that they were investigating options on east-routes.

Mr. Madrid asked if there had been an increase in Redi-Wheels ridership. Ms. Dubost said ridership has been slowly increasing and as more places open up, there should be more paratransit customers.

Chair Baker asked why there were 114 DNOs (Did Not Operate) in October. Mr. Olmeda said the biggest reason was from the contractor MV Transportation and late-night services.

Amy Linehan, Public Affairs Specialist, encouraged the members to apply for an open slot on the SamTrans Measure W Citizens Oversight Committee (COC).

#### 8. CAC MEMBER COMMENTS/REQUESTS

Vice Chair Johnston said his wife was an avid biker and Caltrain rider. He said he wished the ECR route would be as fast in comparison.

Ms. Park said she was enthusiastic as the youth bus pass program that was proposed at the November SamTrans Board meeting.

Iris Chan said there still should be printed material for those that without access to computers and smartphones. She asked if the Art Takes a Bus Rode would be coming back. Mr. Olmeda said it was not planned for the near future, but would get back to the CAC.

Bianca Randall said she had been taking the FCX (Foster City Express) to San Francisco and back most weekdays. She said the ride has experienced much more traffic in the last few months. She said the time to arrive at her destination varies with the amount of traffic. She asked if the arrival times were being adjusted accordingly. Jonathan Steketee acknowledged that traffic patterns are changing. He said the January 2022 runbook will have adjusted timepoints to respond to the changing traffic patterns.



Bob Gomez wished everyone a happy holiday.

Ms. Park thanked the Reimagine team for all their hard work.

Chair Baker noted that the Hillsdale Shopping Center stops need some more wayfinding signage for transferring bus riders.
